2. A Pre-bid Conference for queries/clarifications will be held on **19.11.2020 at 11:00am** in the Communication Section of the DGIPR, Khyber Pakhtunkhwa, situated at Civil Secretariat Complex, Warsak Road, Peshawar.
3. Contracting firms must be registered with FBR and/or KPRA. All applicable taxes will be deducted as per Government policy.
1. Suppliers must invariably mention that the rates are inclusive of taxes.
4. Sealed bid must be accompanied by a bid security for an amount not less than 2% (two percent) of the total tender value (refundable) in the form of call deposit receipt (CDR) issued by any schedule bank of Pakistan in the name of Secretary Information & Public Relations, Khyber Pakhtunkhwa.
5. The bidder shall furnish an affidavit on Rs. 100/- stamp paper stating that the firm is not blacklisted in any government department.
